ROLL OVER YOUR IRA FOR WILDLIFE



AN EASY WAY TO HELP San Diego Zoo Global®

If you are 70½ or older, rather than simply taking your withdrawal this year, you can direct your IRA administrator to distribute a gift from your IRA to the Zoo. Any amount you transfer may count against your required minimum distribution (RMD), and you can direct as much as \$100,000.

MAKING AN IRA ROLLOVER GIFT IS EASIER THAN EVER

- Contact your IRA administrator. (See reverse side for sample letter.) Because of the popularity of the rollover, most administrators provide forms and a procedure to help you make a rollover gift.
- You can direct a transfer of up to \$100,000 to be made this year from your IRA to the Zoo.
- Note: Because you are not claiming the transferred amount as income, you will not receive an income tax deduction for your gift.

TAKING YOUR RMD

- You pay income tax on your distribution
- You may not need or want the money
- Your tax dollars go to the government
- You are limited by the RMD rules

- You will pay no income tax on your gift
